DOCAPOST ACQUIRES CDC FAST FROM CAISSE DES DEPOTS AND STRENGTHENS ITS PRESENCE IN THE E-ADMINISTRATION MARKET

DOCAPOST, a subsidiary of Le Groupe La Poste, announced that they have signed an agreement with Caisse des Dépôts for DOCAPOST to purchase all of the share capital of CDC FAST.

The transaction took effect as from 7 January 2016, at which time CDC FAST changed its name to DOCAPOST FAST.

DOCAPOST FAST has supported the digital transformation of local authorities and public institutions through a broad range of services to establish digital trust since 2006. Today, the company has more than 5,300 customers and 36,000 users.

This acquisition will enable DOCAPOST FAST to step up its development by building on a renowned industrial partner, on complementary business activities and on an extensive customer base. This opportunity gives DOCAPOST the chance to increase its presence in the e-administration market, which is one of its strategic growth drivers.

Connected to Le Groupe La Poste's Digital Services Business unit and backed by a network of 4,600 employees located at 50 different locations in France, DOCAPOST supports companies and administrations in their digital and mobile transition while helping them optimise their business processes.

For Pierre-André Florat, Chief Operating Officer of DOCAPOST FAST, *"being integrated into DOCAPOST, a partner of CDC FAST for several years, is going to enable the company to achieve a new stage in its development, in particular by building on this new shareholder's commercial and technical expertise."*
